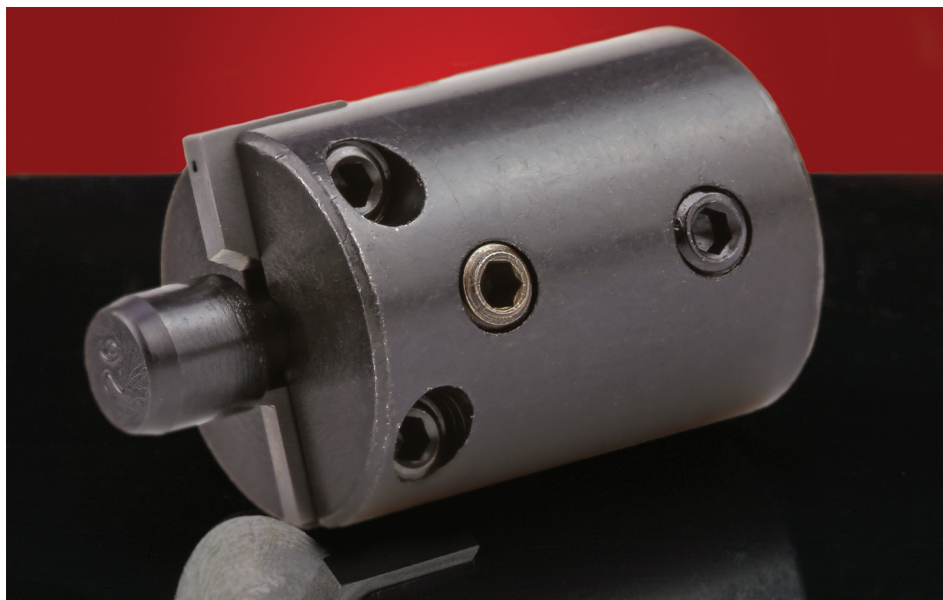

Trims case to length and chamfers inside and outside in one step!



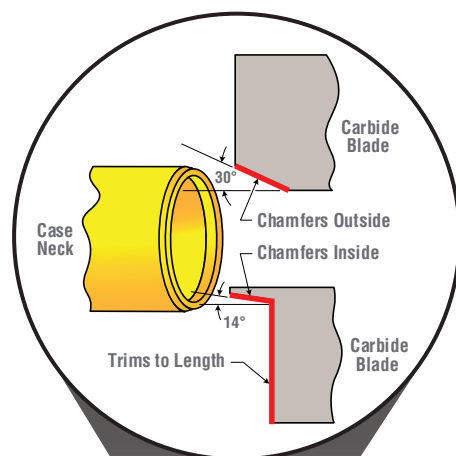
Forster Products' **3-in-1 Case Mouth Cutter** is the first carbide case trimmer accessory that performs three functions simultaneously. In one simple step, this product:

- Trims the case to length
- Chamfers the inside case mouth to an angle of 14°
- Chamfers the outside case mouth to an angle of 30°

To further save you time, the **3-in-1 Case Mouth Cutter** is the first cutter to employ high-quality blades made from US-manufactured carbide. They should never need sharpening if used exclusively on brass cases. The carbide cutter blades are factory adjusted on the blade holder to ensure precise cutting.



1 Primer Pocket Cleaner (PPC175: for .175" primer pockets) (PPC210: for .210" primer pockets)	Removes primer and powder residue in brass cases after each firing to ensure proper primer seating. Used with the Primer Pocket Center (PPCE02) .	
2 Outside Neck Turner (OT1010)	Removes excess brass from the outside neck wall. When used after sizing, this process produces a neck wall with an even thickness.	
3 Neck Reamer (NR1###) (Order by bullet diameter.)	Removes excess brass from the inside case neck wall. (Used before sizing.)	
4 Universal Hollow Pointer (HP1016: 1/16", for rifle rounds) (HP1008: 1/8", for handgun rounds)	Hollow points most calibers of rifle and pistol cartridges in 1/16" and 1/8" size drills. Long and short case trimmer bases are available for hollow pointing long and short cartridges.	
5 3-in-1 Case Mouth Cutter² (3CUT-224: 224 pilot) (3CUT-243: 243 pilot) (3CUT-257: 257 pilot) (3CUT-264: 264 pilot) (3CUT-277: 277 pilot) (3CUT-284: 284 pilot) (3CUT-308: 308 pilot)	Chamfers case mouth inside and outside, and trims case to length, all in one step.	
6 Primer Pocket Chamfering Tool (PPCT01)	Chamfers military primer pockets, removing most, if not all, the crimp from military cases. Used with the Primer Pocket Center (PPCE02) .	
		The Case Trimmer Power Adapter (PA1000) allows your case trimmer to be powered by your electric screwdriver or power drill.

1. All Case Trimmer Accessories may be used on the Forster Original, Power and Classic Case Trimmers, except the 3-in-1 Case Mouth Cutter and the Outside Neck Turner, which may be used only on the Original and Power Case Trimmers. Depending on the case length, the Long Case Trimmer Base (CT1010-CTB103) may be required for use on the Original Case Trimmer.

2. Pilot size indicates bullet diameter.
